

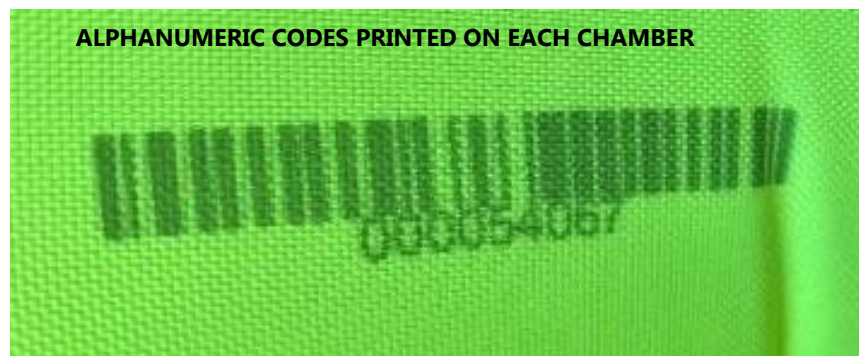

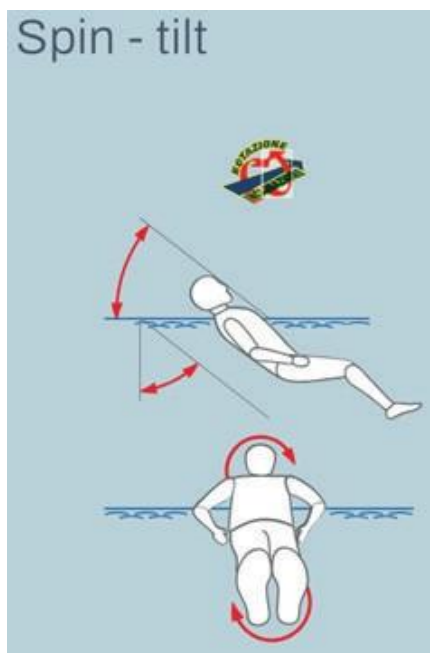

A floatation chamber with double compartment in PA 420 PU COATED material with electronically-controlled high-frequency welds. Designed to contour to the body's ergonomics and optimise positioning in the water. Provides optimal positioning and perfect stability in the water. The thrust rotates an unconscious person and angles them so as to keep their airway free of water. What's more, once the chamber is inflated, it is possible to swim unimpeded to reach safety or to quickly climb into a lifeboat.

ACTIVATION SYSTEMS:

- Automatic - Upon falling into the water, the system automatically activates within 5 seconds of submersion, with the inflation of the floatation chamber. Automatic activation is possible with the salt activator UML MK5 or Hammar, through the dissolution of a water-soluble tablet.
- Oral - This type of inflation is achieved via the special mouth tube, with a non-return valve and protective cap. To inflate the chamber, simply blow into the tube.



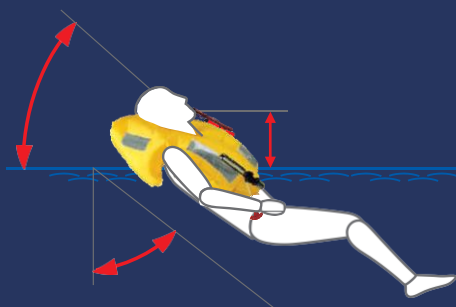

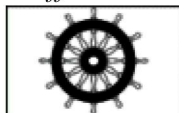
